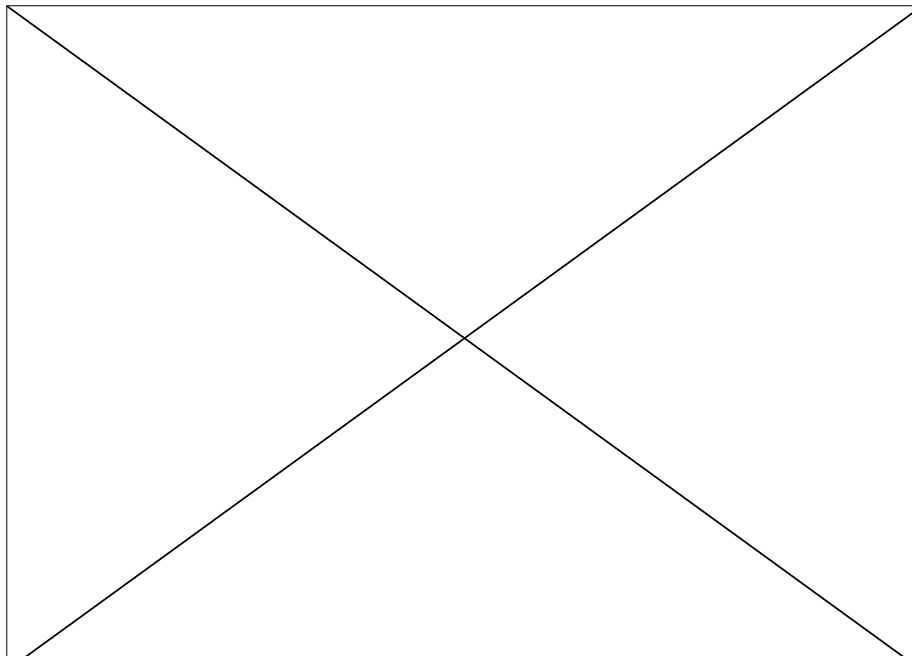

# Result: Shift in Public Opinion

2008 poll by World Public Opinion, U. of Maryland, polled 6,063 people in 17 nations outside the US: Majorities in only 9 of the 17 countries believe Al Qaeda carried out the attacks.

The LAST Polls in the USA were done in 2006:

40 percent of Americans now think there has been a "coverup" around 9/11. —Zogby

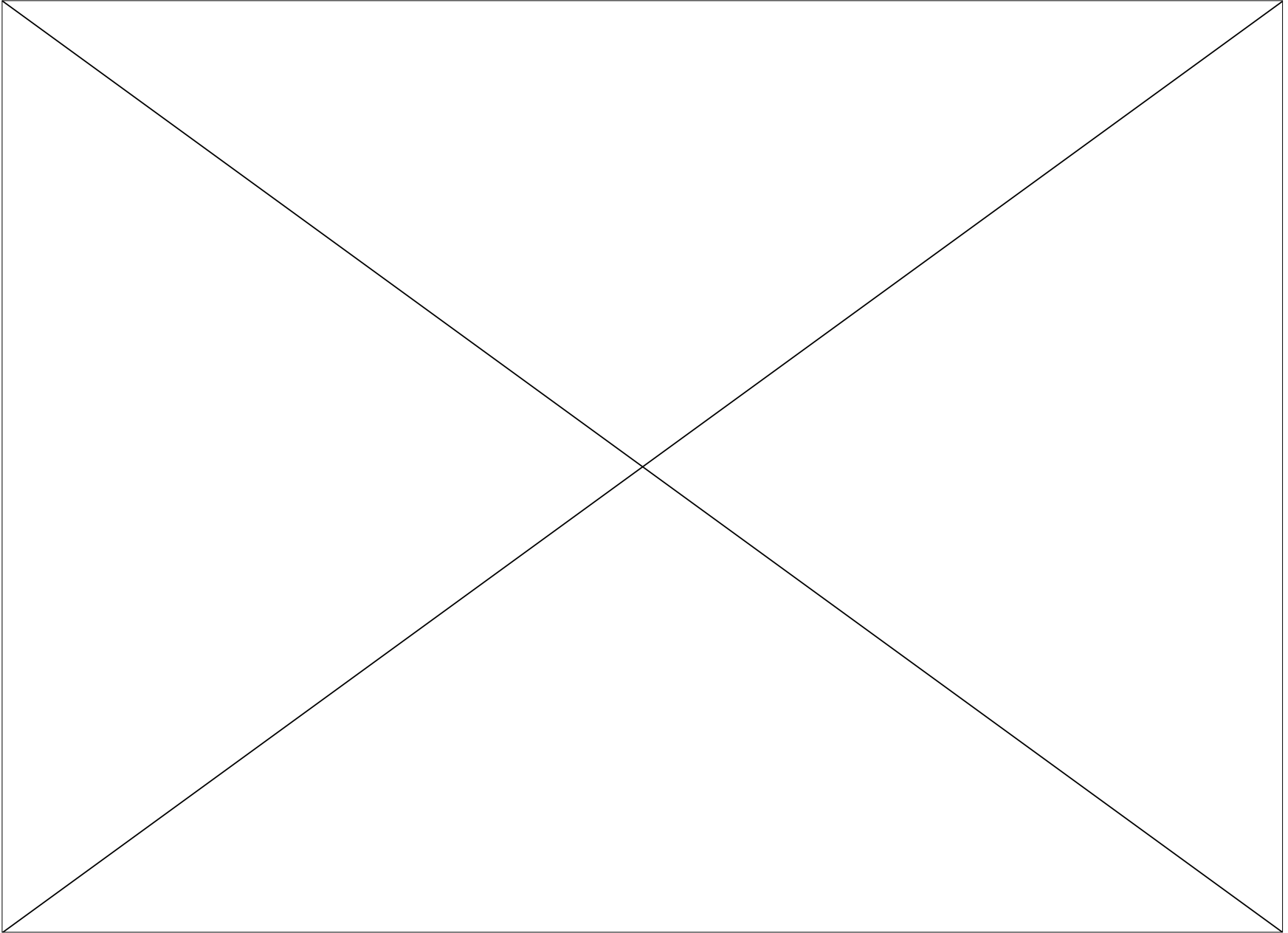

2009: In response to emerging independent science on the 9/11 attacks, nine corporate, seven public, and two independent media outlets aired analytic programs investigating the official account.

Increasingly, the issue is treated as a scientific controversy worthy of debate, rather than as a "conspiracy theory" ignoring science and common sense.

Eight countries have allowed their publicly-owned broadcasting stations to air the full spectrum of evidence challenging the truth of the official account of 9/11.

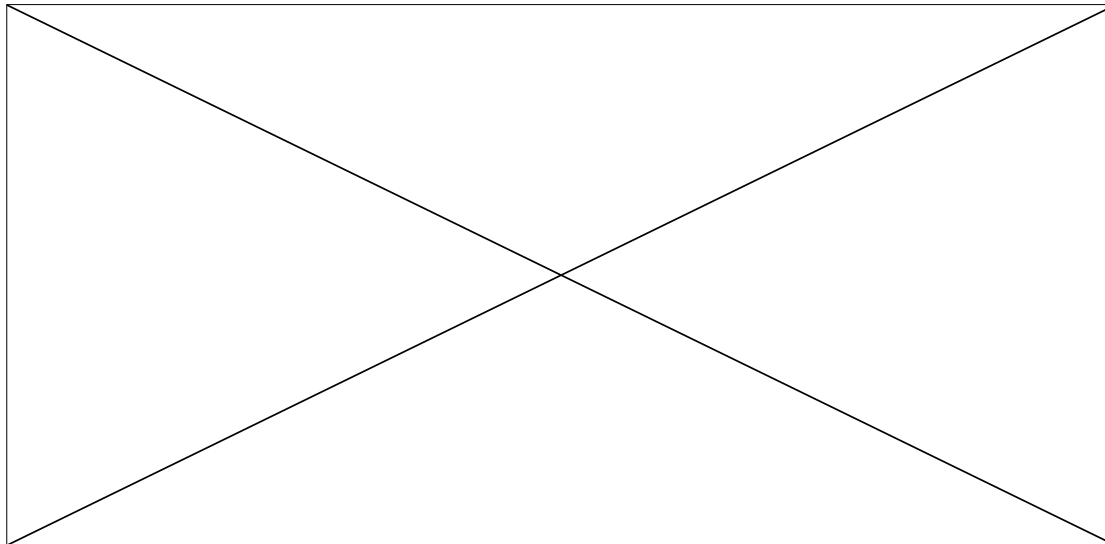

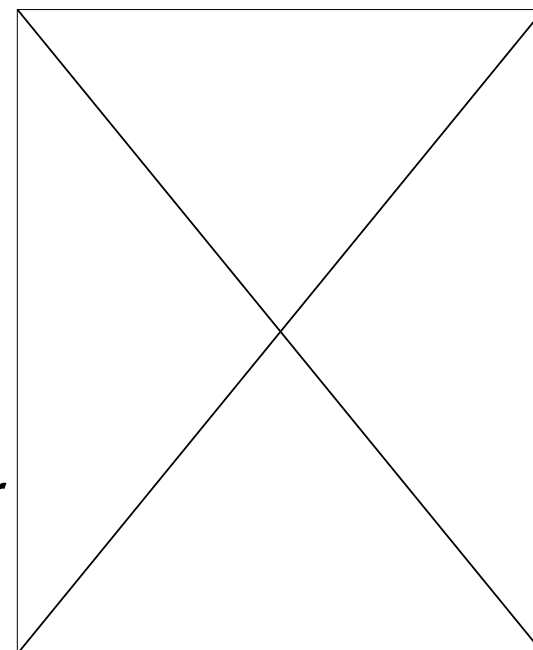
# White House's Cass Sunstein:

Discovered recently! January 2010 — needs to be exposed.

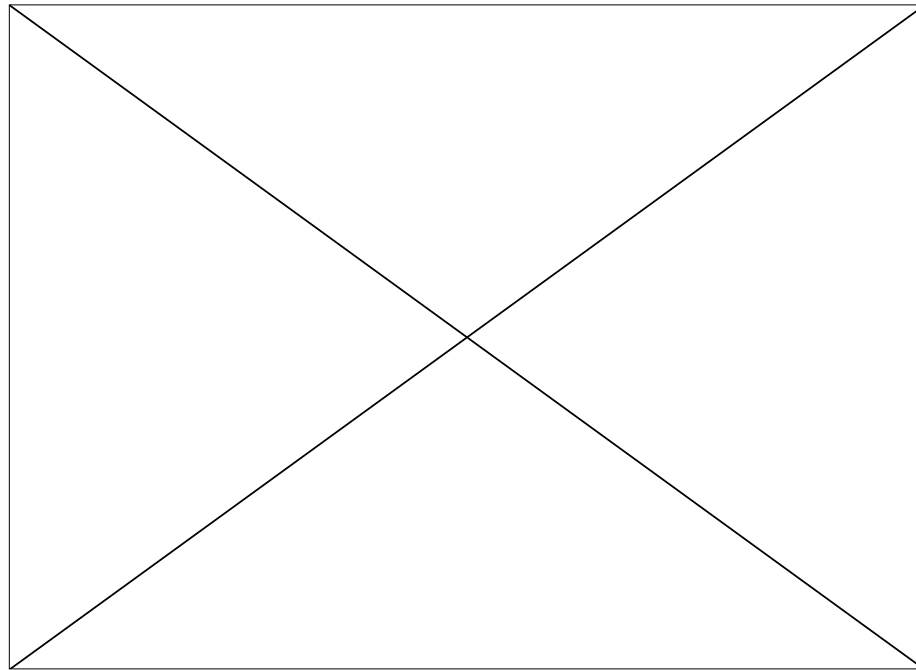

# Answer:

1st, 4th, Amendments to Bill of Rights:

First Amendment:

\* First Amendment – Freedom of speech, of the press, Freedom of Religion, and of assembly; right to petition,

Fourth Amendment:

\* Protection from unreasonable search and seizure.

# 4th Amendment

*“The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation, and particularly describing the place to be searched, and the persons or things to be seized.”*

Judge Louis Brandeis:

Asserted Right to Privacy inherent in 4th Amendment

called it your “Right to be Left Alone.”

# The beginning of a Mass Movement

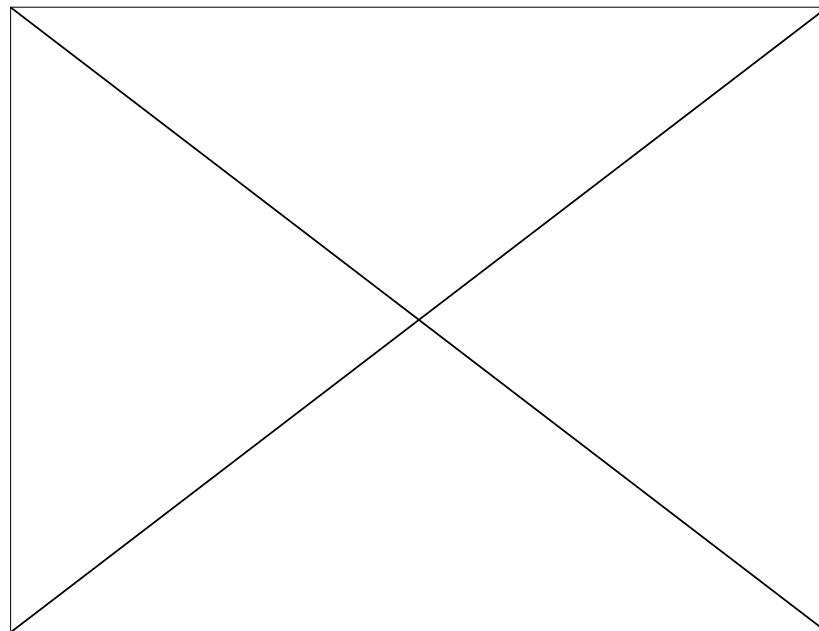
We connected to inherent human need for Truth

Lessons of Pittsburgh, Cambridge, and Left Forum: We ARE a part of a broad “Anti-War” Movement.

NOT a part of a Socialist/Stalinist Lead wing of that “Anti-War Movement”

We stand for Truth.

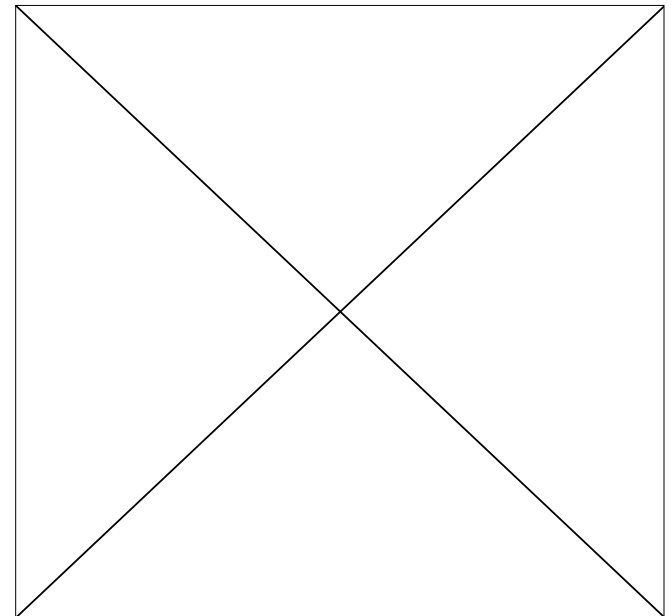
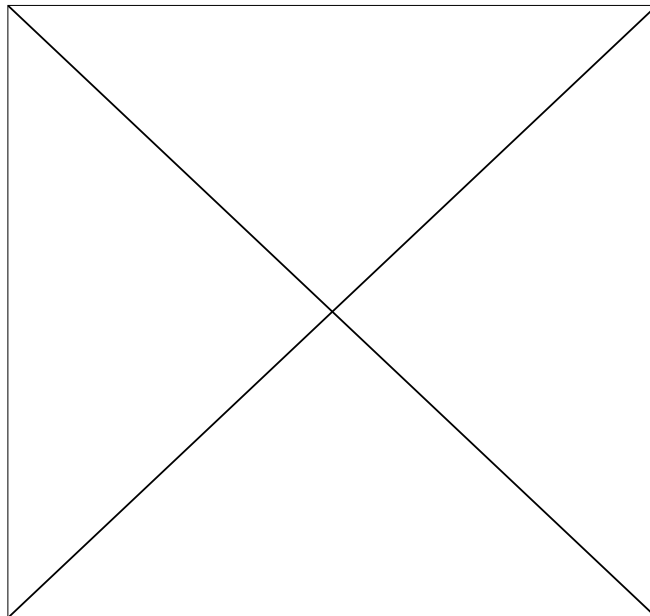
Postmodernism holds that there is no truth, there is only subjective opinion.

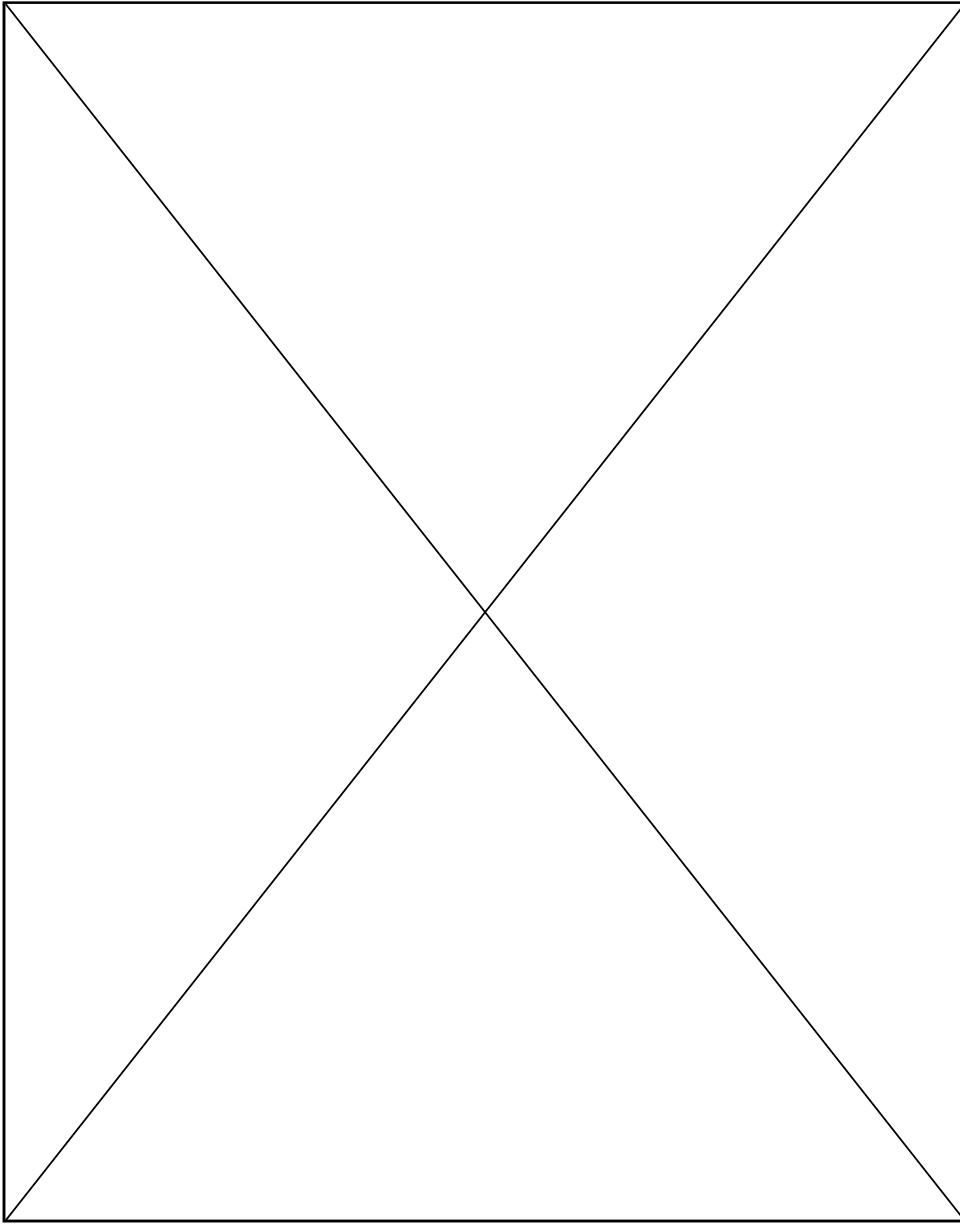


# Who is this Truth Movement?

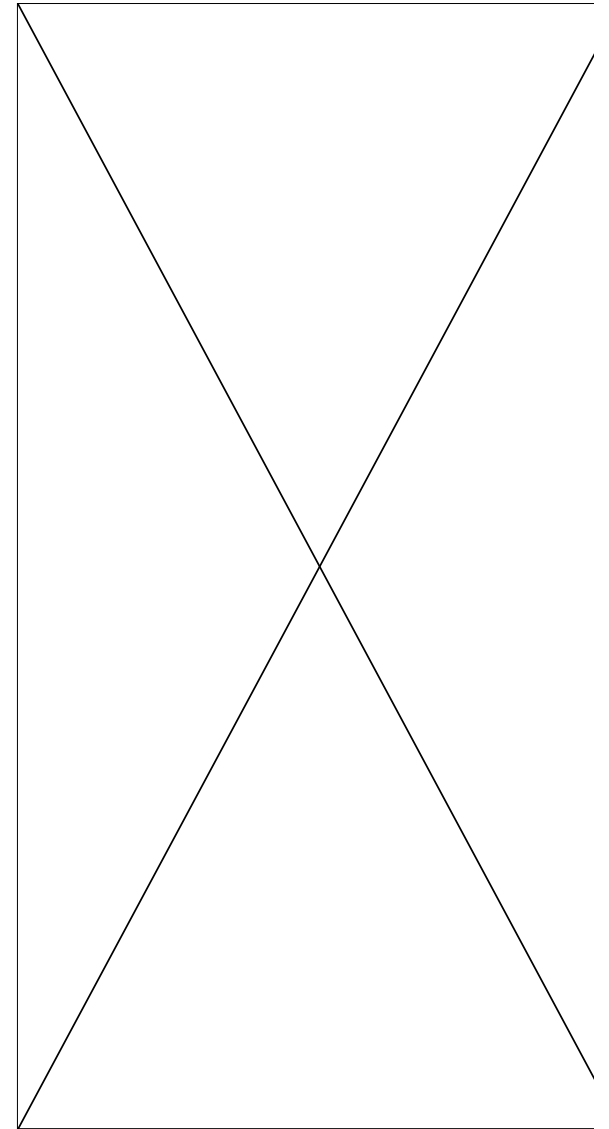

# Misprision Case Law

Chief Justice Marshall, in *Ex parte Bollman*, 4 Cranch [8 U. S.] 75, 126: **'It is not the intention of the court to say that no individual can be guilty of this crime who has not appeared in arms against his country. On the contrary, if war be actually levied, that is, if a body of men be actually assembled for the purpose of effecting by force a treasonable purpose, all those who perform any part, however minute, or however remote from the scene of action, and who are actually leagued in the general conspiracy, are to be considered as traitors.'**



# Misprision Case Law II

Treason: Primarily defined in US Constitution as ‘levying war against the United States,’

**“To constitute a levying of war there must be an assemblage of persons in force, to overthrow the government, or to coerce its conduct. The words embrace not only those acts by which war is brought into existence, but also those acts by which war is prosecuted. They levy war who create or carry on war.”**

—Circuit Court, N.D. California.

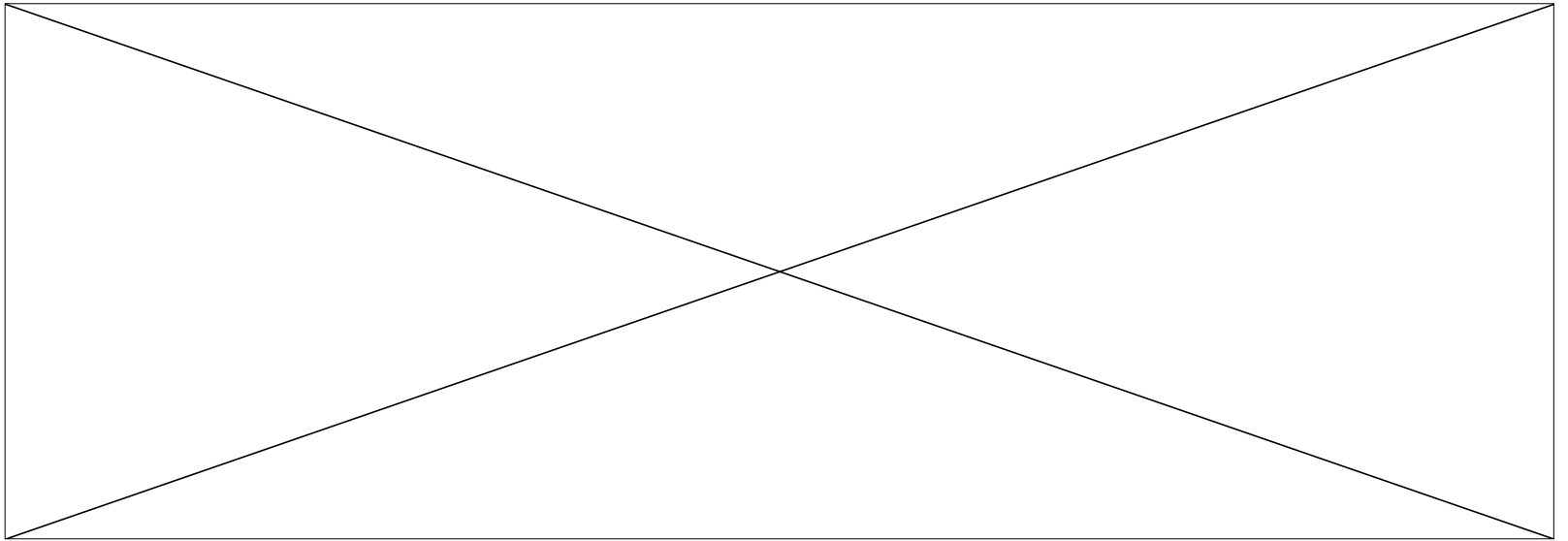

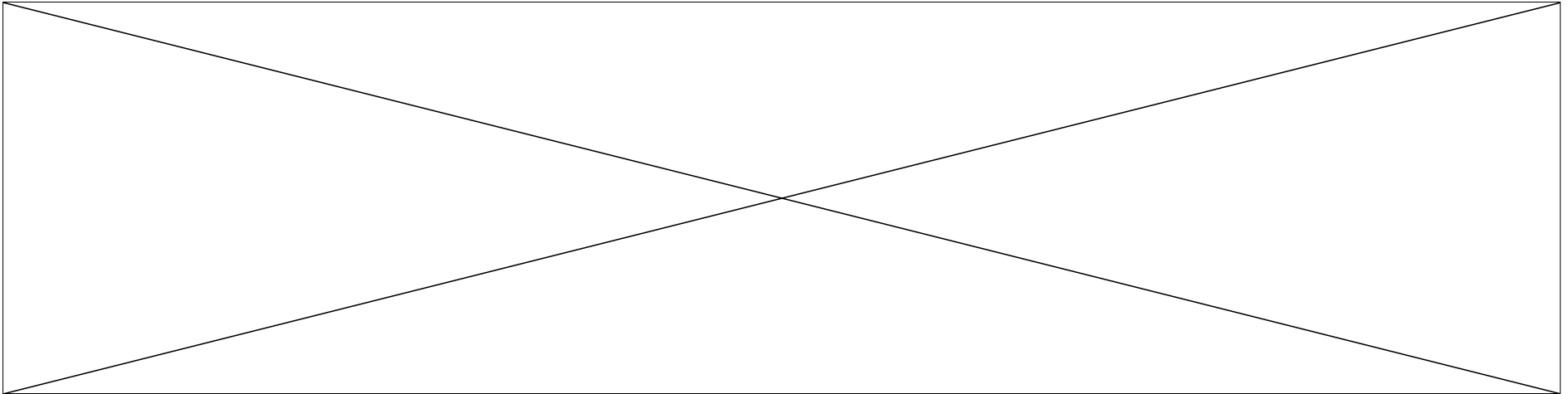
- Judge Pomaco levied NO fine for “Harassment”

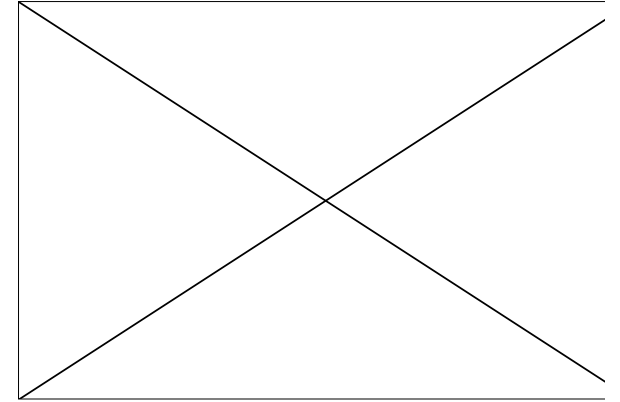

**FLAWS IN JUDGE'S REASONING:** resumptons about "international terrorists" in these documents.
